Eligibility Criteria

Please indicate if the patient satisfies the following criteria:

For the treatment of adult patients with Waldenström’s macroglobulinemia (WM) (190818004); AND

The patient:

Is ≥ 18 years of age; AND

Has a clinical and definite histologic diagnosis of relapsed/refractory (RR) WM; OR

Is treatment-naïve and considered to be unsuitable for standard chemo-immunotherapy regimens; AND

Meets at least one criterion for treatment according to consensus panel criteria from the Seventh International Workshop on Waldenström’s Macroglobulinemia (IWWM-7); AND

Has measureable disease requiring treatment as defined by a serum IgM level > 0.5 g/dl; AND

Has an Eastern Cooperative Oncology Group (ECOG) performance status between 0 and 2; AND

Has adequate hepatic and renal function; AND

The physician is an oncologist or experienced in the use of anticancer therapies

OR

None of the above applies
