Coverage of Cialis (tadalafil) *Once-A-Day 2.5mg and 5mg* is **NOT** provided for female patients, males < 18 years, patients receiving nitrate therapy or patients with psychogenic or primary erectile dysfunction. Cialis (tadalafil) *Once- A-Day* will be eligible for reimbursement only if the patient satisfies the criteria listed below and if the patient does not qualify for coverage under any other drug plan or government mandated program. If the patient is covered under another drug plan or government mandated program, the prior authorization program, as part of your drug benefits, may cover the portion not paid for by the primary plan. **Coverage is dependent on group setup.** Failure of therapy is defined as a serious side effect, contraindication and/or ineffective treatment response. If "none of the above criteria" is indicated, the patient will not be eligible for reimbursement. **For Quebec plan members, please refer to the RAMQ exception drug criteria, if applicable.**
