Non-metastatic Castration-Resistant Prostate Cancer (427492003)

- The patient:
 - Is \geq 18 years of age; AND
 - Has a diagnosis of non-metastatic castration-resistant prostate cancer (NM-CRPC); AND
 - Has experienced disease progression (clinical, radiographical or biochemical) despite bilateral orchiectomy; OR
 - Has experienced disease progression (clinical, radiographical or biochemical) despite other androgen deprivation therapy including:
 - Separate trials of anti-androgens Casodex (bicalutamide) AND flutamide; AND
 - Use of LHRH agonists goserelin (Zoladex) or leuprolide (Lupron or Eligard) OR an LHRH antagonist degarelix (Firmagon); AND
 - Will continue use of a gonadotropin-releasing hormone (GnRH) analog unless has had a bilateral orchiectomy; AND
- The prescriber is an oncologist, urologist or other specialist in the treatment of prostate cancer.

OR

Metastatic Castration-Sensitive Prostate Cancer (722103009)

- The patient:
 - Is \geq 18 years of age; AND
 - Has a diagnosis of Castration-Sensitive Prostate Cancer (CSPC); AND
 - Has metastatic disease documented by one or more bone lesions; AND
 - Has Eastern Cooperative Oncology Group (ECOG) performance status of 0-1; OR
 - Has received prior docetaxel treatment meeting the following criteria:
 - Received a maximum of 6 cycles of docetaxel therapy for metastatic CSPC; AND
 - Received the last dose of docetaxel within last 2 months; AND
 - Has maintained response to docetaxel therapy (i.e. stable disease or better); AND
- The prescriber is an oncologist, urologist or other specialist in the treatment of prostate cancer
