If the patient is covered under another drug plan or government mandated program, the prior authorization program, as part of your drug benefits, may cover the portion not paid for by the primary plan. Initial Criteria (3 months duration):

Physician confirms the patient meets the drug’s Health Canada approved indication for the treatment of postmenopausal women or men (≥18 years of age) with advanced breast cancer (T990000077) as initial endocrine-based therapy for their metastatic disease

- Patient is concurrently using an aromatase inhibitor; AND
- The prescribing physician is an oncologist; AND
- Patient is a postmenopausal woman, and:
 - Has inoperable, locally recurrent disease; AND
 - Has no prior therapy for advanced breast cancer; AND
 - Has ECOG ≤ 1;

OR

Physician confirms the patient meets the drug’s Health Canada approved indication for the treatment of women or men (≥18 years of age) with advanced or metastatic breast cancer (T990000077) whose disease progressed after prior endocrine therapy

- Patient is concurrently using fulvestrant; AND
- The prescribing physician is an oncologist; AND
- Patient is a woman, and:
 - Has no prior therapy for advanced breast cancer; AND
 - If pre- or perimenopausal, will be treated with a luteinizing hormone releasing hormone (LHRH) agonist; AND
 - Has ECOG ≤ 1

Renewal Criteria (approval period of 1 year):

- Patient satisfies initial criteria; AND
- No disease progression or unacceptable toxicity
