Eligibility Criteria

Rheumatoid Arthritis (Xeljanz or Xeljanz XR)

For use in combination with methotrexate (MTX) for reducing the signs and symptoms of rheumatoid arthritis (RA) (69896004), in adult patients with moderately to severely active RA.; AND

- Patient is ≥ 18 years of age, AND
- Patient has tried and inadequately responded to a minimum 12 week trial of Methotrexate, AND
- Will be used
 - in combination with Methotrexate, OR
 - In cases of intolerance to Methotrexate, as monotherapy,

AND

Physician is a rheumatologist or is experienced in the management of RA

Ulcerative Colitis (64766004) (Xeljanz only)

- Patient is ≥ 18 years of age, AND
- Has a diagnosis of moderately to severely active ulcerative colitis (Mayo score 6 to 12 with endoscopic sub-score ≥2 and rectal bleeding subscore ≥ 1), AND
- Has tried and failed conventional therapy, including immunomodulators, corticosteroids, and/or a TNFα inhibitor, AND
- Physician is a gastroenterologist or is experienced in the management of ulcerative colitis

Psoriatic Arthritis (156370009) (Xeljanz only)

- Patient is ≥ 18 years of age, AND
- Patient has moderate to severe psoriatic arthritis with ≥3 tender joints out of 78 and ≥3 swollen out of 76 (dactylitis of a digit counts as one joint each); AND
- Has tried and failed conventional treatment (i.e. DMARDs); AND
- Physician is a rheumatologist or is experienced in the management of psoriatic arthritis.
