Assyst Point of Sale

Version Synchronization - Our version numbers have taken a jump in sequence. This realignment of version numbers for both POS and Rx-A are due to the major field expansions and for easier identification when both modules are in use.

Field Expansions

Select fields within the application have been expanded for better performance. These are:

Accounts Receivable

The statement and the history statement quantities have been expanded due to the new field size expansion in the pharmacy.

Assyst-POS Application Changes

Accounts Receivable

Statement printing (plain paper) has had some changes made to accommodate windowed envelopes. The Laser Feed Adjust field should be set to 150 as a starting point for this option, and changes can still be made per site. This will now move the whole page where previously it did not.

The Cash Receipts window will now display a 'File Record in Use' message when bringing up the account instead of when the entry is entered and then saved.

Over applied payments will no longer occur when using an account with an additional Bill To.

When printing to a printer (that is not laser) the window ranges now follow the standard behaviour, along with the lookup function (F12) and the tab order.

When printing Customer Statements, the Customer Receipts will generate and print as requested. This was only an issue when requesting customer receipts from the statement run.

Attachments

A new purge routine has been added.

Handheld

Receive New OnHands and Misc Download Routine – Audit records will be created for items that have the same balance on hand.

Misc Download Routine - Audit records will only be created when the update flag is set to Yes.

When downloading into a new purchase order, the PO is automatically saved and any items downloaded are added and saved.

Invoice Posting

When zooming in on a P type invoice (and saving the change) the item descriptions will display correctly.

Item Maintenance

The promotion field will no longer accept non-numerical values.

Item Quick Maintenance

When changing multiple price and target margins, the selected items will save and display correctly.

Loyalty

The Card Maintenance Lookup has been streamlined to function the same as other application lookups.

MultiStore

GL Batches marked as transferred will now be deleted when the posting date is older than a month.

Promotion Maintenance

The promotion number field will no longer accept dashes or decimals.

Ordering

PharmaChoice downloads will check for related items when adding into both promotions and purchase orders.



Value Drug Mart – We have extended the wait time to pull back invoices by 15 seconds. We have also added a prompt to manually start the download cycle again.

Receiving

When receiving by keyboard, the SHIFT F11 will now open the Price Tickets window. This feature was available in the character version and is now usuable in the GUI interface.

Receive and order dates (during a receiving session) can no longer be saved as all zeroes.

Reminders

The initials field is now active even when Authorizations has not been turned on. This allows reminders to be resolved the same day when initials have been set.

Reporting

Receipt Exception Report – (In the select range window, with Full Dates selected in Preferences) If the sort option is changed by clicking on the headers in the grid, (with the date column being the last sort) the sort will go back to the initial sequence, instead of sorting alpha/numeric. If the date fields are changed, the window will refresh automatically.

Shelf Labels

Minor changes made for improved functionality of the window.

Till Functions

When performing a return on a staff sale (and the item is on a price table) the return price will now properly reflect the price of the item.

Wireless Handheld

A CF-STATUS error will no longer display when scanning an Rx. This is only applicable for sites that have RxA integrated with the POS and are using a Providen device.

Order Entry

When adding a comment to a new or unshipped order, an invalid handle message will no longer occur.

When creating an order (and using a template) and if the item does not have sufficient on hands, an error will no longer appear when the item is added to a purchase order.
